- **What is the Reduced Utility Rate Program?**

This program is intended for customers who are considered long-term low-income. This program is not intended for short-term assistance due to things like temporary job-loss.

- The program is limited to the first fifty (50) approved applications.

- **What is the reduction?**

This program allows eligible customers to have their Base Fee, which is the minimum fee paid regardless of how much water is used, reduced to 50% of the current fee. Customers accepted into the program are still required to pay the usage-portion at 100% of the current rates.

- **Application & Renewal Process:**

- This benefit expires at the end of every calendar year. Customers must re-apply every year to continue receiving this benefit. (The first fifty (50) applications reviewed and approved will receive the reduced rate for the application year.)
- Applicants must provide a copy of their completed Federal Income Tax Return from the previous calendar year.
- Applications which are received by the City of Hermiston prior to April 15, and are subsequently approved, will receive a credit dating back to January 1 of the eligibility year. However, customers must pay their full bill until eligibility is determined.
- Applications which are received by the City of Hermiston after April 15, and are subsequently approved, will only receive the benefit for the remainder of the current calendar year.

- **What if I do not file a Federal Income Tax Return?**

Customers who are not required to file a Federal Income Tax Return must provide alternative documentation including:

- Bank Statements for the previous calendar year

- **Federal Income Tax Filing Requirements**

Below are a handful of common tax filing arrangements. These will be used to determine if you were required to file taxes the previous year. You are required to file Federal Income taxes if your income is above any of the thresholds shown for your filing status:

- **Single filing status:** \$14,600 if under age 65 / \$16,550 if age 65 or older
- **Married filing jointly:** \$29,200 if both spouses under age 65 / \$30,750 if one spouse under age 65 and one age 65 or older / \$32,300 if both spouses age 65 or older
- **Married filing separately** — \$5 for all ages
- **Head of household:** \$21,900 if under age 65 / \$23,850 if age 65 or older
- **Qualifying widow(er) with dependent child:** \$29,200 if under age 65 / \$30,750 if age 65 or older
