## BUSINESS ELECTRIC SERVICE AGREEMENT

The undersigned hereby applies for electric service with **HERMISTON ENERGY SERVICES** (hereinafter called the "Municipality") and in consideration of the acceptance of this application agrees with the Municipality as follows:

1. As soon as electric energy shall be available, the undersigned will purchase monthly from the Municipality not less than the minimum amount of electric energy which shall from time to time be determined by the City Council of the Municipality and will pay therefore, and for all additional electric energy used by the undersigned, the price which shall from time to time be fixed therefore by the City Council
2. The undersigned will grant to the Municipality at its request the necessary rights, privileges and easements to construct, operate, replace and repair and perpetually maintain on the property owned or occupied by the undersigned, and in or upon all roads, streets or highways abutting said property, its lines or lines for the transmission or distribution of electric energy, and will execute and deliver to the Municipality any conveyance, grant or instrument which the Municipality shall deem necessary or convenient for said purposes or any of them. All service lines supplying the undersigned with electric energy and all switches, meters and other appliances and equipment constructed or installed by the Municipality on said property, except so much thereof, if any, as shall be paid for by the undersigned, shall at all times be the sole property of the Municipality, and the Municipality shall have the right of access to said property to repair and service, and upon the discontinuance of service for any reason to remove the same.
3. The undersigned shall have all the rights and privileges granted to customers under the Customer Service Policies of the Municipality or any amendments thereof and will comply with and be bound by such Customer Service Policies and all the rules and regulations as may from time to time be adopted by the City Council of the Municipality.
4. The acceptance of this application by the Municipality shall constitute an agreement between the Municipality and the undersigned upon the terms herein above set forth.
